NOTING that under the Memorandum of Understanding (MOU) concerning the Establishment, Administration and Operation of the JCBRN Defence COE (JCBRN Defence COE Operation MOU), dated 26 October 2006, the Sponsoring Nations are establishing the JCBRN Defence COE as a COE that will be made available to NATO;

NOTING the Concept for the JCBRN Defence COE, which provides for a value-added contribution to the transformation efforts of NATO in the field of defence against chemical, biological, radiological and nuclear weapons;

CONSIDERING further that with MCM-236-03, dated 04 December 2003, the Military Committee has established that a COE may be granted the status as an International Military Organisation under the Protocol on the Status of International Military Headquarters set up pursuant to the North Atlantic Treaty, dated 28 August 1952 (Paris Protocol) by the North Atlantic Council;

Unless a meaning is specified within this MOU and its follow-on documents, the NATO Glossary of Terms and Definitions (AAP-6) and the definitions laid down in the Allied Acquisition Practices Publication (AACP-1) PART I (Guidelines and Sample Provisions for Memoranda of Understanding) will apply.

The following definitions apply for the purposes of this MOU and its follow-on documents:

- a. Allied Command Operations (ACO) Supreme Headquarters Allied Powers Europe (SHAPE) and the other agencies and organisations subordinate to SACEUR.
- b. Allied Command Transformation (ACT) HQ SACT and the other agencies and organisations subordinate to SACT.
- c. Background Information Information not generated in the performance of this MOU.
- d. Centre of Excellence (COE) A nationally or multi-nationally sponsored centre to support NATO, as defined in MCM-236-03.
- e. COE Network A structured network of COEs supporting the NATO Command Arrangements (NCA).
- f. Foreground Information Information generated in the performance of this MOU.
- g. Framework Nation (FN) The Czech Republic as the nation which provides the initial infrastructure, the equipment and the other support in accordance with the provisions of the JCBRN COE Operation MOU and which holds the position of the JCBRN Defence COE Director.
- h. Host Nation (HN) The Czech Republic, as the nation on whose sovereign territory the JCBRN Defence COE is established.
- i. Information Any information, regardless of form or type, including that of a scientific or technical nature, and also including photographs, interim and final reports, manuals, threat data, experimental data, test, designs, specifications, processes, techniques, inventions, drawings, software including source code, technical writings, sound recordings, pictorial representations, and other graphical presentations, whether in magnetic tape, computer memory or any other form and whether or not subject to copyrights, patents, or other legal protection.

- 1. NATO Command Structure (NCS) NCS as defined in MC 324/1 (revised), dated 07 May 2004.
- m. NATO Military Committee (MC) The NATO committee that provides military advice to the NAC.
- n. North Atlantic Council (NAC) The Council established pursuant to Article 9 of the North Atlantic Treaty.
- o. Other Customers Any non-NATO nation, organisation or agency that uses the services and/or products provided by the JCBRN Defence COE and is not a Participant.
- p. Programme of Work (POW) The document setting out the JCBRN Defence COE activities in the domains of policy, concept and doctrine development, exercise, experimentation, training and education, and the provision of services/subject matter expertise.
- q. Sponsoring Nations (SNs) The nations that are collectively proposing the JCBRN Defence COE to NATO and that provide manning, equipment, funding and other support or resources to the operation of the JCBRN Defence COE.
- r. Steering Committee (SC) The main body set up by the SNs for guidance, oversight and decisions on all matters concerning the establishment, administration and operation of the JCBRN Defence COE.
- s. Technical Arrangements (TAs) Follow-on arrangements concluded among the Participants.

SECTION II PURPOSE

he purpose of this MOU is to lay the foundation for the functional relationship between HQ ACT and the SNs regarding the JCBRN Defence COE as a NATO COE for the facilitation of the transformation in the field of CBRN defence.

- 1. The JCBRN Defence COE is a multi-nationally sponsored COE for all issues related to the transformation in the field of CBRN defence.
- 2. This MOU does not constitute a command relationship between SACT and the JCBRN Defence COE.
- 3. The JCBRN Defence COE is not part of the NCS, but forms part of the wider framework supporting the NCA. As such, it supports and complements SACT's efforts by providing CBRN defence expertise to NATO's military transformation with first priority.
- 4. HQ SACT as the designated NATO-entity for the coordination of the NATO-accredited COEs and the COE-network will co-ordinate and provide all NATO requests to the JCBRN Defence COE and monitor their performance.
- 5. The JCBRN Defence COE will be assessed according to criteria as set out in IMSM-0416-04 of 11 June 2004. The accreditation is subject to the approval by the MC and a final endorsement of the JCBRN Defence COE by the NAC. Once accredited, the JCBRN Defence COE will be screened periodically by HQ SACT to ensure it continues to meet the criteria. If the JCBRN Defence COE fails to meet the appropriate criteria, HQ SACT will recommend the necessary steps to be taken in order to meet the accreditation criteria. Continued failure in meeting the accreditation criteria could result in loss of accreditation as a COE.
- 6. All support by the JCBRN Defence COE will remain subject to the approval and allocation of resources by the SC.
- 7. TAs may be concluded among the Participants to amplify and provide additional details not covered in this MOU.

SECTION IV MISSION AND RESPONSIBILITIES

The mission of the JCBRN Defence COE is to:

- Support NATO and its military transformation in the field of CBRN defence through and in support of HQ SACT; and
- b. Within a JCBRN Defence COE Steering Committee (SC)-approved POW, assist SNs, other NATO-nations and other Customers in their CBRN defence-related efforts.

- a. Provide competent and timely advice to NATO on CBRN defence issues, to include support to the development of a NATO CBRN reachback capability;
- b. Test and validate CBRN defence-related NATO concepts and doctrines through experimentation;
- c. Assist in CBRN defence doctrine development by leveraging knowledge and lessons learned;
- d. Contribute to the NATO standardisation in the field of CBRN defence;

1. The SC will decide on the JCBRN Defence COE annual POW. For co-ordination of all NATO requirements in the POW, HQ SACT will provide the NATO requests for services or products to the JCBRN Defence COE. A HQ SACT representative will be invited to participate in the relevant SC meetings on a non-voting basis to advise the SC on the POW with regard to the NATO requirements and priorities.

2. HQ SACT and the JCBRN Defence COE will, on a continuous basis coordinate the execution of the POW. Emergent NATO requests will be forwarded to the JCBRN Defence COE by HQ SACT for appropriate consideration.

SECTION VI LEGAL CONSIDERATIONS

- 1. Arrangements that are in force among the Strategic Commands and the SNs may apply to the national participation and/or the activities of the JCBRN Defence COE.
- 2. This MOU is not intended to conflict with the laws of the SNs or international law that may apply. In any occurrence of conflict the Participants will notify and consult with each other. In the event of such conflict the law of the SNs or international law will prevail.
- 3. This MOU does not create any rights and obligations under international law.
- 4. With regard to the products generated by the JCBRN Defence COE on request of HQ SACT, the SNs will ensure, subject to the restrictions applied by the owner of the information, that HQ SACT, for the benefit of the Alliance and within its mission to transform NATO, has the:
 - a. Right of use and distribution of all Foreground Information; and
 - b. Right of use and distribution of all Background Information required to appropriately utilise the product;

Whereas, under these provisions, HQ SACT, in principle, will not be charged for any use or distribution of any type of information and will itself not derive any revenue from any distribution. Further details and particular requirements or restrictions may be laid down in a TA.

ADDITIONAL PARTICIPATION AND WITHDRAWAL

- 1. The joining of any new Participant to this MOU will be considered among the current Participants. The joining of a new Participant will be accomplished through a Note of Joining (NOJ) signed by the new Participant and all the current Participants. It will come into effect with the last signature thereto but not before the corresponding NOJ to the JCBRN Defence COE Operation MOU comes into effect. A sample NOJ is included in Annex A to this MOU.
- 2. Any Participant may withdraw from this MOU on presentation of twelve months' written notice to HQ SACT, which will immediately notify the other Participants about such notice. Any withdrawal by a SN from the JCBRN Defence COE Operation MOU will also constitute a withdrawal from this MOU, whereas the FN will ensure the appropriate information of HQ SACT.

SECTION XII FINAL CONSIDERATIONS

- 1. This MOU will come into effect on the date of the last signature thereto. This MOU will remain in effect until such time as the Participants decide otherwise in writing or if the accreditation of the JCBRN Defence COE is revoked or if HQ SACT withdraws from this MOU or if the JCBRN Defence COE Operation MOU ceases to be in effect. In the latter case HQ SACT will be informed by the FN accordingly.
- 2. Notwithstanding the termination of or withdrawal from this MOU, the relevant financial and security provisions in this MOU will continue to remain in effect until all activities under this MOU have been concluded.
- 3. Each TA will be governed by the same conditions as this MOU, unless otherwise specified in the TA itself. In case this MOU is terminated, all of its follow-on TAs will terminate automatically.
- 4. One original of this MOU is signed in the English language. HQ SACT will be the custodian of the MOU. As such, HQ SACT will provide all Participants with certified copies of this MOU and all related documents.


